VOLATILITY FRONTIER



MISTAKE TO AVOID



"To develop a science of managing, we shall first have to determine what programs managers use." (H. Mintzberg 1973)



INNOVATION

Innovation:

- *spirit of progress*, the first and most effective element in an individual and a company;

- *desire to know* what is the true success, **to travel** the road to get there, the desire **to correct** the mistakes and tendencies that delay progress, willingness **to accept** new ideas, attitude, behaviour and meeting them;

- *anxiety to get a result*, the enthusiasm to strive for excellence, to promote energy, the ability to postpone a successful a temporary forgery to the increase of a vital and permanent benefit.

- **spark of the spirit** of progress emerges from within, from the soul, in a moment of noble resolution, even after a long analysis, but must never be extinguished or weaken.



THE HISTORY OF INNOVATION

INNOVATION: innovation in *exaptational behaviour*, not only for products, services, process and business models. (Darwin C. 1860 – Schumpeter J. A. The Theory of Economic Development 1934)

ORGANIZATION: the world, from crisis to crisis, slowly slides into recession. Organizations try new challenges and opportunities. In today's interconnected business, it's impractical for a company to stop innovation projects until the worst blows over. *They live exaptation to improve!*

PREADAPTATION. (Darwin C.) **ADAPTATION.** (Gould - Vrba)

POSTADAPTATION: the Science of Management, (H. Fayol, **1916**) H. Mintzberg-The Nature of Managerial Work 1973

EXAPTATION: source of innovation, creativity and diversity in evolutionary sciences; the wealth of networks beyond selection and market mechanisms.



MANAGEMENT

Management like cognitive processes is the basis of the programs and organizations, but *a* role to be played by a manager is merely a categorization of *what* the manager does.

Each program is, in effect, a description of *how* one specific aspect of a role is carried out: planning, informing, detecting, interrupting, scheduling, checking, monitoring, allocating, coordinating, housekeeping, inspecting, cleaning, verifying, controlling; keeping the organization, all the programs, in fighting trim. Is it also an exaptation process?

The classic reporter's "5 W": Who? What? When, Where, Why?

The 7 latin words by Cicerone Marco Tullio (De oratore):

- Quis ? (Who?) Quid ? (What?) Cur ? (Why?) Ubi ? (Where?)
- Quando ? (When?) Quemadmodun ? (In which way?)
- Quibus adminiculis ? (By which means?).



MANAGEMENT

The manager's job is described by a set of composite functions. *H. Fayol* (1916) gave 5 basic managerial functions – *planning, organizing, coordinating, commanding and controlling*. Then with specific content, it was given to managers one of their first acronyms: *POSDCORB*. *Planning, Organizing, Staffing, Directing, Coordinating, Reporting, Budgeting.*

J. Schumpeter, the economist most well-known for his view of innovation, stressed the idea that the entrepreneur's key role is innovation: "everyone is an entrepreneur only when he actually 'carries out new combinations' and loses that character as soon as he has built up his business" (The Theory of Economic Development 1934).




